

Mortgage Application Checklist – PLEASE SEND DOCUMENTS IN PDF FORMAT ONLY

- MyMortgages.ie Online Application Form - to be submitted **online**.
- Photo ID - if Passport ensure same is signed and 4 corners visible OR if Driver's License, include both sides of driver's license (scanned not photo).
- Marriage Certificate.
- Certificate of Income – to be completed & **MUST** be stamped by employer / Letter from employer on headed paper confirming no stamp available.
- Employment Detail Summary from previous year – available from www.ros.ie - If earning variable income, please provide 3 years EDS
- Pay Slips – 3 months of the most recent.
- Current Account Statements – last 6 months (most recent date to be within 2 weeks)* including Revolut, N26 etc.
- Savings Account Statements – last 6 months (most recent date to be within 2 weeks)*.
- Credit Card Statements – 3 most recent.
- Loan / Mortgage Statements – most recent.
- Copy of all existing life, income protection and pension policies.
- €500 fee – however this fee is not payable once you incept your mortgage protection policy with our sister company www.MyLifeCover.ie **PRIOR** to Mortgage Application being submitted.

N.B. If you have ever had late or missed payments on a credit card or loan account, you need to advise us of this when submitting your documentation as if you are declined due to adverse credit history and we were not made aware of this prior to submitting application, then a fee of €500 is payable to MyMortgages.ie.

* Please make sure the name, address & account number are on all bank and credit card statements.

Self-Employed Applicants Also Require

- Financial Statements for the last 2/3 years if more advantageous – **MUST** be signed by directors and accountant.
- Tax Clearance Certificate – both personal & company, where applicable.
- Notice of Assessment – Chapter 4 for last 2/3 years if more advantageous.
- Form 11 Return Summary for last 3 years.
- Last 6 months business bank statements.
- 6 months statements for all business loans.

Self-Build Applicants Also Require

- Copy of Grant of Planning Permission & Conditions.
- Tailte Éireann map with coordinates, if in place, in colour.

Overseas Buyers or If You Have Lived Abroad in The Past 3 Years Also Require

- Credit Report from the country you resided in.
- 6 months bank statements for all bank accounts, credit cards and loans etc. from the country outside of Ireland.
- Copy of your Curriculum Vitae.
